 - b. **CE43 – Road Furniture**
- 3) Company with experienced in road furniture - guardrail work for the past 8 years with a project value minimum RM1.0 million and above in a single contract.
- 4) The brief scope of works are as follows :-
 - a) Traffic Management Plan - To provide Traffic Management as per current MHA and PLUS requirement.
 - b) Site Assessment - To carry out inspection on the actual site condition inclusive underground mapping utilities.
 - c) Removal of Existing Guardrail - Remove, dismantle and transport the existing guardrail component to the contractor's own dumping ground as directed by Plus Berhad
 - d) Installation of hot dipped galvanized guardrail - To supply and install new guardrail beam, new galvanized steel post, new galvanized packer, new galvanized steel guardrail components inclusive of necessary ancillary items, packing pieces and bolt, nut and washer

The Agreement must specify the lead partner, the equity participation of each joint venture/consortium company, and include a clause stating that all members of the joint venture/consortium company are jointly and severally liable for the said joint venture/consortium company. Tenderers are not allowed to change the joint venture/consortium company after the tender closing date
5. All costs associated with the above Tender shall be borne the tenderer. Tender Documents received later than the specified date and time will not be considered and PLUS Berhad shall not be liable to any losses, damages, claims or demands (either direct or indirect) that may be suffered by the tenderers in connection with its participating in this Tender.
