 - d) To remove existing road marking; and to apply new pavement marking with high performance thermoplastic reflective marking, anti-skid red colour pavement, vibraline and pavement marking tape.
 - e) To conduct retro-reflectivity testing on thermoplastic road marking and skid resistance test on thermoplastic road marking and anti-skid pavement surface.
 - f) To supply and install other road equipment such as road stud, linear delineator system (LDS), solar L.E.D flashing light, flexible post and lane block and plastic delineator post
