### Frequently Asked Questions (FAQ) - BELANJA DAN MENANG Campaign

### 1. Who is the organiser of this contest?

The contest is jointly organised by Projek Lebuhraya Usahasama Berhad (PLUS) and Payments Network Malaysia Sdn Bhd (PayNet).

## 2. When is the contest period?

- Employees, representatives, distributors, advertising, and promotional agencies of the Organiser and their immediate family members.

- Via MyDebit card using MPay, NTT Data, or Pinelabs terminals; OR
