1. Tenderers who are interested to participate in this tender must have experience in providing professional **consultancy services related to Architectural Works within the last 10 years** in the appointment of a work contract.
2. Tenderers must be incorporated and registered in Malaysia.
3. Tenderers with Bumiputera status.
4. The tenderer is allowed to submit only one (1) tender. Any tender found to have submitted more than one (1) tender will have their participation to be automatically disqualified.
5. Tender Deposit amounting to **Ringgit Malaysia: Five Thousand Only (RM5,000.00)** via online bank transfer from a licensed bank operating in Malaysia under the name "**PROJEK LEBUHRAYA USAHASAMA BERHAD**" along with the Tender Document to be submitted on or before the Tender Closing Date and Time.

1. Each company is only allowed to participate as a single entity. However, tenderers may appoint their own sub-consultant(s) registered in Malaysia as part of their Tender Document submission.

 - iv) Any other valid documentary evidence issued by relevant authorities, to substantiate Bumiputera eligibility.
 - c) Validated proof of project experience with minimum 10 years' experience in Architectural Works.
