- b. **Security Monitoring & Patrol** - Continuously monitor toll plaza surroundings, toll lanes and movement of Toll Crew/public, and conduct regular patrols to identify and report any suspicious activities or damage to PLUS property.
- c. **Traffic & Crowd Management** - Assist in managing traffic, minor vehicle breakdowns at toll lane and crowd control, including preventing highway users from approaching Toll Crew or toll booths and directing them to the appropriate channel
- d. **Incident Reporting & Daily Documentation** - Record and report all incidents, suspicious activities and observations in the security logbook, and submit daily reports to the Toll Crew for verification at the end of each shift.
- e. **Operational Discipline & Compliance** - Ensure security guards comply with PLUS instructions, applicable Ministry of Home Affairs requirements, designated working hours, attendance and break arrangements, cash declaration requirements, and all prohibited activities while on duty.
